

The wedi Shower System PRO Certification Workshop will expand upon your fundamental knowledge of the wedi Shower System. In this one and a half day training seminar, you will learn the full scope of applications possible with wedi products and the complete wedi Shower System. The training will cover flooring, shower system and steam room applications in detail.

Upon completion of the wedi PRO Certification Program, you will qualify for the wedi PRO warranty extension, which may expand the warranty period to 15 or 20 years on qualifying wedi projects\*\*.

The wedi PRO Certification Program will cover lodging and food. Travel expenses and arrangements are excluded, and are the responsibility of the attendee.

#### wedi PRO Certification and Warranty Program

In addition, and subject to the terms of wedi's general warranty as stated above, wedi now offers a certification & warranty program "PRO". Under this program, the warranty period is extended if each the following general criteria are met:

1. wedi offers an extended period warranty of 15 and/ or 20 years to licensed installation contractors and companies ( the "installer").

(A) 15 Years of extended product warranty are offered for wedi product system installations including the exclusive use of a. a wedi Fundo Shower Base and drain; b. wedi Building Panels ( including use of wedi vapor barrier as applicable in steam room installations or ice rooms) to cover all shower walls exposed to water, or wall surfaces considered wet areas Res2, Res3, Res4, Com2,Com3,Com4 by definition of the TCNA Handbook of Ceramic, Glass, and Stone Tile Installation, but installed at least 6 inches higher than every water outlet/shower head; c. wedi Joint Sealant and Fastener System; d. a wedi curb, ramp or floor even entry and floor transition waterproofing provided by wedi Building Panels or wedi Subliner Dry waterproofing membrane system.

No other, product besides wedi product may be installed in the shower area and provide a tileable surface. (B) 20 years of extended product warranty are offered under the same terms as shown under section (A), but the wedi shower system also includes a. either, or all of the following wedi products: wedi seat; wedi bench; wedi niche; b. extended waterproofing of the entire bathroom floor using wedi Building Panel or wedi Subliner Dry waterproofing sheet membrane (wall flashing/ waterproofing must cover at least 6 inches from floor into the wall surface.

2. The warranty extension(s) may apply only, if the wedi product(s) have been installed by a wedi "PRO" certified installer holding a valid certificate issued by wedi. The wedi "Pro" certification is valid for 4 years from the date of wedi's issuance of a "PRO" program certificate, after corresponding and successful attendance of the "Pro "program certification classes. These classes are not regular wedi certification classes and must be advertised by wedi as "PRO" classes. Only authorized wedi personnel may certify installers within the "PRO" program. The wedi "PRO" certification expressly does not cover any warranty claim occurrences related to, but not limited to, any workmanship issues, or other situations not under the direct control of wedi, or not directly caused by a defective wedi product(s) (manufacturing defect). wedi's general limitations, Conditions of Coverage, and Exclusive Remedies as listed for wedi's General Warranty , apply to all "Pro" warranty extensions, and remain in full effect, unless stated otherwise in the sections related to the" PRO" warranty extensions.

3. The "PRO" warranty extension(s) may only apply to projects and installations fully registered with wedi. Needed information for a successful registration of project/' installation include a. Full name of owner(s) of residence/ building; street address and number; City; State; Zip-code; b. Name of wedi product installer, PRO certification ID, and company including full company contact / address; c. minimum 2 digital photos of the wedi installation prior to installation of surface coverings, and showing a close up of the entire extend of the wedi product installation; d. copy of the purchase invoice for wedi products.

The "Pro" warranty extension(s) are non- transferable and extended to only product installer and original homeowner/ building owner.

4. In addition to limitations shown under wedi's General Warranty, Conditions of Coverage, and Exclusive Remedies, all claims made under wedi "PRO" warranty extensions require the repair, re-installation or replacement of wedi product found to be defective (manufacturing defect), through a wedi "PRO" certified installer. wedi product(s) must be used in any such claim mitigation as authorized by wedi.

5. The maximum Coverage extended within the "PRO" warranty extension programs is limited to Twenty-Five Thousand and 0/100 US Dollars (US\$ 25,000.00) plus the cost of wedi product needed for a reinstallation, per one single project/ building registered with wedi.

6. Qualifying extended warranty registrations for projects must be submitted to wedi within 30 days from the purchase date of the wedi products used (date of purchase invoice).
